Exhibitor Contract

1. Exhibitor agrees to abide by all applicable laws, ordinances and regulations pertaining to health, fire prevention, public safety, business licenses and sales tax
2. All exhibitors must be in place and staffed no later than 10:30 am December 2nd 2017. Exhibits must be opened and staffed during show hours. Exhibitor not dismantle their booth before 8:00pm Saturday, December 2nd 2017.
3. The exhibitor agrees to indemnify and hold harmless the Holiday Craft Festival, its directors, officers, sponsors, agents, employees, Roxanne Stangle and the Town of Minden from any and all claims, causes of action suits, damages, injuries and losses to any person or goods or connection in any way with the renting space in the festival.
4. The producers will not be liable for refunds or any other liabilities, whatsoever, for the disruption of the Festival due to reasons of enclosure in which the materials be produces, being, before, or during the show, destroyed by fire, theft or other calamity, or by any act of God, public enemy, strikes, statutes, ordinances or cause beyond the Producers control. Producer has the option to cancel or change the Festival at any time, for any reason and will return all booth fees to the exhibitor.
5. Exhibitor agrees to confine all display and selling activity within the assigned booth space, refraining from placing signs, goods or other material within or on aisle space.
6. Producers reserve the right to deny display of items that have not been listed on the application but are offered at the Festival.
7. Exhibitors agrees to permit photographs to be taken of their booth and products to be used for the purposes of promotion in print, website or Television.
8. CANCELLATION AND REDUCTION POLICY- Any cancellation or changes MUST BE IN WRITING and received by our office no later than 30 days prior to the date of the show. After cancellation date NO REFUNDS WILL BE MADE.
