- A limited number of booths will be available for Home Based Businesses on a first come first served basis (e.g. Avon, Mary Kay, Pampered Chef, WildTree, Scentsy etc.)
- All tables must have table coverings.
- Food items must be packed and labeled (samples may be served w/ approved valid health permit.)
- All exhibitors are responsible for sales tax on items sold (7.1) rate subject to change.
- NV Department of Taxation "ONE TIME SALES TAX RETURN" form will be issued to all vendors.
- Tax Forms must be turned in to AMANDA ALDRIDGE before exhibit tear down.
- The following items are not permitted to be sold: Drug paraphernalia, sex items, weapons, including but not limited to guns, knives, swords, bows and arrows, items related to alcohol)
- Exhibitors must remain open until the end of the event (No tear-down prior to 3 pm)
- There will not be a rain date and no refunds will be given for weather related issues.
- Withdrawal requests must be submitted by letter or email to AMANDA ALDRIDGE by April 1 to receive a full refund. No refunds will be made after this date.
- "No shows" may result in non-participation in next year's event.
- We will not be responsible for loss, theft or damage of any items you have brought to the show.
